FY2015 State by State Figures on Medicaid Expenditures for School Based Services

For nearly 30 years, schools across the Nation have used Medicaid dollars to cover certain health-related services for Medicaid eligible children. Children covered by Medicaid may receive primary or preventive services in a school-based center, such as hearing and vision screenings. States also may use Medicaid dollars to help provide services described in a child's special education plan under the Individuals with Disabilities Education Act (IDEA). This includes services such as occupational and physical therapy, nursing, mental health, and aides in the classroom. Medicaid also covers health services for eligible children through the Early and Periodic Screening Diagnosis and Treatment Services (EPSDT).

In 2015, the Federal share of Medicaid funding for school-based services was more than \$2 billion, with States matching nearly \$1.8 billion. **Under the Republican plan to cap Medicaid expenditures, state elected officials may be forced to cut funding to schools that provide special education services to students with disabilities.** Below you will find state by state school-based Medicaid funding with the federal share listed separately.

Note: These numbers reflect total school-based Medicaid funding. Due to reporting requirements under Medicaid, data is not available on the specific portion of these figures dedicated only to students served under IDEA.

Examples of State Activities for Medicaid Outreach:

The goal of these outreach activities is to create pressure on state and local leaders, and their state and national organizations, to lobby against and publically oppose the republican Medicaid plan, including:

- Write an Op-Ed to highlight the importance of school-based Medicaid to the state budget.
- Encourage local elected officials and other prominent state leaders to speak-out in support of school-based Medicaid. Ask these individuals to put pressure on national organizations to lobby against the republican plan.
- Issue a release to state reporters on how much federal funding for school-based Medicaid, described in this chart, is in jeopardy should the republican plan be adopted.
- Request your state Medicaid office release school district level figures to highlight the importance of Medicaid reimbursements for schools, and request the head of the agency issue a release to state reporters on the potential impact of the republican plan.
- Tour a school to see Medicaid services being delivered as part of a child's special education services. Work with the school district to host a press conference with school officials and parents to emphasize the importance of Medicaid funding for children with disabilities.
- Hold a tele-town hall with your local school superintendents, school board members, or teacher unions to discuss the importance of protecting Medicaid funding for schools.

Note: Both teacher unions, the National Education Association and the American Federation of Teachers, as well as the Superintendents Association have offered to help offices create events to highlight the importance of school-based Medicaid. Reach out to these organizations.
